Mayor's Message

It's hard to believe our summer is already winding down! Some of you are packing or already off to college, others are getting ready for the new school year, and some of us are probably ready for cooler temperatures. Hopefully you have had an enjoyable and fun filled summer.

On Tuesday, August 7th we participated in National Night Out and had a record amount of participation with 19 parties in Minnetrista! Our Chief of Police, National Night Out coordinator Dave Lock, Councilmembers Pam Mortenson, John Tschumperlin, and I were able to attend many of the gatherings. It was great to see so many of you! A big thank you to all that coordinated a neighborhood party! A big thank to our Police Department for all their time and efforts, making this a huge success.

Recently a resident asked me: "What's new at City Hall?"

One of the hot topics in many communities around Lake Minnetonka is Vacation Rental by Owner. We have seen an uptick in the number of properties that are listed and after listening to residents, gathering information, discussion and debate, the Council passed an ordinance banning VRBO's in our community.

We have also been discussing the need for a water tower in our south west area. Discussion items have included location, water pressure, fire-fighting capabilities, storage, current and future demands, and costs. No final decision has been made yet, more discussions and considerations will occur.

Those of you that live on our gravel roads have noticed less dust and wash-boarding this summer. With the purchase of equipment, we are now able to do our own dust abatement which allows multiple applications at or below the same cost.

In May we hired Robert Goodman as our new Building Inspector, welcoming him to our staff on June 5th. A big thank you to Jack Molin who stepped in to help on an interim basis.

At a recent City Council meeting, Chief Falls reported the Crime Fund interest in fund-raising 100% of the costs to complete our gun range. We're exploring opportunities to off-set and/or cover the on-going costs with other communities and through public membership fees.

The Council saw a draft budget proposal at our work session on August 6th and we must certify a budget and levy to the county by September 28th. The final budget is then certified in December. The final budget cannot be higher than the preliminary, but it can be lower. Council and Staff will continue to work on details and modify the budget this fall. Our goal is to be prudent with your tax dollars and still be able to meet our obligations and needs.

Water Pollution

innetrista's City Code states pet owners/custodians are responsible for cleaning up any waste and disposing of it in a sanitary manner whether on their own property, on the property of others, or on public property. The City asks that you pick up after your pet to reduce the movement of bacteria into water and areas where it can be stepped on.

When pet waste is left and is later rained on, it leaches bacteria, viruses, and parasites into the storm water which can threaten the health of humans and animals. Pet waste also contains nutrients that promote weed and algae growth in lakes and rivers. This is the same as when too much fertilizer is used—it turns waterbodies a mucky, green color. Picking up dog waste helps keep our community clean, safe, and beautiful!

Public Works Updates

n 2017 the City Council approved the purchase of dust abatement equipment, and his year the Public Works department began dust abatement with that equipment in house. In the past, dust abatement was done by contracted vendors one time per year at a cost of \$45,000.00 - \$70,000.00. This year the cost will be between \$15,000.00 - \$20,000.00. As a new operation for Public Works, finding the right application rates is a learning curve. Once application rates are determined, we will apply dust abatement monthly beginning in June and going through September. This schedule will allow for any necessary grading between applications to help avoid the dreadful wash boarding that can develop.

Public Works will also be cleaning and televising sanitary sewer lines in the following areas: Yellowstone/Palmer Pointe area, Co Rd 44 area, North & South Saunders, Halstead Dr area. This project is expected to begin in August and continue through mid-September with fall hydrant flushing and street sweeping expected to take place in October. 2017 Financial Audit and Report Completed

he City's Comprehensive Annual Financial Report for the year ended December 31, 2017 has been completed. It was presented to the City Council at the May 21 Council Meeting by the City's auditors Clifton Larson Allen. The City received an unqualified opinion on its financial report which is the best opinion the City can receive on the annual audit.

The full audit report is available at the City's website on the Finance page and is labeled "2017 Comprehensive Annual Report (CAFR)." The City has sent the report to the Government Finance Officers Association for review to receive the Certificate of Achievement for Excellence in Financial Reporting, the City has received this award the last 13 years. The CAFR award is presented to government units whose Comprehensive Annual Financial Reports achieve the highest standards in governmental accounting and financial reporting.

The auditors reported that the City remains in very good financial condition. For 2017 the actual expenditures for the general fund were \$171,889 lower than the budgeted general fund expenditures. Revenues came in slightly lower than projected at \$42,337 lower than budgeted revenues in the general fund. The City ended the year with the general fund having a total fund balance of \$2,897,248 and an unassigned fund balance of \$2,519,530. This represents a healthy reserve level of 58% and 50% of the 2018 General Fund Budgeted expenditures of \$4,995,270 respectively.

A Letter From Our Chief

raining requirements for police officers vary greatly across the country and Minnesota has very high standards for law enforcement professionals. To become a licensed Police Officer in Minnesota, you are required to have a college degree, be licensed, and earn a number of certifications in a wide variety of proficiencies in order be employed.

The Minnesota Peace Officer Standards and Training Agency (POST) governs training and licensure for police officers. In addition to the initial hiring requirements, Police Officers are required to earn an additional forty-eight hours of continuing education every three years in order to maintain their license.

There are essentially two types of training; internal and external training. Internal training is on the job training conducted at our police department by our own certified instructors. Internal training generally has a narrow focus in areas like the initial sixteen week field training program for new officers, use of force, taser, and firearms training.

External training is more broad based and consists of a wide variety of training topics by certified instructors from outside of our agency. Some examples include monthly on-line training through the League of Minnesota Cities, emergency vehicle operation, pursuit intervention tactics, crime prevention, first aid, crime scene management, mental health awareness, domestic assault intervention, and interview and interrogation techniques.

Of our current thirteen licensed police officers, nine are certified instructors in areas ranging from DARE, Use of Force, Firearms, Taser, Hobble Restraint, Lidar, and crime prevention. We also have two certified Glock Armors and two certified AR15/Rifle Armors on staff.

Training is key to safe and successful operations. We are constantly evaluating our training and operations to ensure that we are providing the very best police service possible to the communities we serve.
